- He / She has been fully initiated in the Catholic Church (received Baptism, Holy Communion, and Confirmation)
- Be an active Catholic, be registered at a Catholic Parish, in good standing with the Church (e.g. has not married outside of the Catholic Church; not cohabiting)
- Not the father or mother of the one to be baptized
